**Re: Regulatory requirements for Cyco Ryzofuel to ensure compliance as per the *Fertilizers Act* and *Regulations* prior to legal import and/or sale in Canada.**

Fertilizer and supplement products are regulated under the authority of the *Fertilizers Act*, which is administered by the Canadian Food Inspection Agency (CFIA). The *Fertilizers Act* is the legislative authority under which the Canadian Food Inspection Agency (CFIA) monitors and controls fertilizers and supplements **sold in or imported into** Canada. The *Fertilizers Act and Regulations* are available on the CFIA's Fertilizer website: <http://www.inspection.gc.ca/english/plaveg/fereng/ferenge.shtml>.

Although certain products are exempt from registration, they are still regulated and must meet all of the standards and requirements set forth in the *Fertilizers Act* and *Regulations* in order to be sold in or imported into Canada. As such, these products must still comply with safety and labelling requirements, as set out in the *Fertilizers Regulations*, before it can be legally sold in the Canadian marketplace.

The Canadian Food Inspection Agency's (CFIA) fertilizer and supplement activities will concentrate on verifying that products are safe for humans, plants, animals and the Canadian environment. In addition to an ongoing focus on the safety of fertilizer and supplement, the CFIA continues to verify that products are properly labelled to avoid product misrepresentation in the marketplace and protect consumers.

This product currently meets the definition of a specialty fertilizer. A specialty fertilizer is defined as (a) recommended for use only on household plants, urban gardens, lawns or golf courses, or in nurseries or greenhouses.

These products are exempt from registration, but are still regulated and must meet all of the standards and requirements set forth in the *Fertilizers Act and Regulations* in order to be sold in or imported into Canada.

**These products do not require a pre-market assessment prior to legally being imported and/or sold in Canada.**

**We are currently not conducting label reviews at this time.**
